

The American Association of Immunologists IMMUNOLOGY2023TM REIMBURSEMENT POLICY AAI Undergraduate Faculty Travel Grant - Undergraduate Faculty -

Subject to the limits set forth below, the AAI Reimbursement Policy allows for the reimbursement of expenses incurred while on authorized AAI travel.

- 1. Expenses will be reimbursed upon the presentation of properly prepared reimbursement requests signed by the claimant and approved by the AAI Executive Office. All expense reimbursement requests must be accompanied by receipts. Requests without receipts will not be honored. Receipts are detailed documents issued by the vendor; credit card statements are not acceptable. Eligible expenses will only be reimbursed after the conclusion of the meeting. If a second recipient (undergraduate student) was approved, each recipient must submit a separate expense reimbursement request. All expense reimbursement requests should be submitted by August 31, 2023. Log in to your AAI profile at account.aai.org/login.htm to submit a PDF of your completed reimbursement form with receipts. Reimbursement requests will be accepted beginning May 30, 2023.
- 2. Airfare will be reimbursed at the lowest possible excursion rate (economy class) and **must be at an advanced purchase rate or equivalent**. Limits for airfare are based on the circumstances of the travel and economy class/standard airfares offered at the time of travel. Lowest airfares may require stopovers. Upgrades will not be reimbursed and are at the discretion and expense of the traveler. Expenses associated with changing travel arrangements after the initial reservations have been made will not be reimbursed unless the change is a result of program rescheduling. Reimbursement for airfare, including baggage fees, will be limited to a maximum of \$600. If travel does not originate from the award recipient's city of employment, the AAI Office must be notified in advance. Any other exceptions to these conditions must be approved by the AAI Office in advance of purchase.
- 3. Reasonable expenses for ground transportation (cabs, buses, Uber, Lyft, shuttles, etc.) associated with the activity will be reimbursed to the traveler at actual cost. Travelers will be reimbursed for transportation to and from the airport and their home, and to and from the airport and their hotel. Other transportation expenses incurred during the meeting are not reimbursed. Limousine and town car expenses are not generally reimbursed unless equivalent to public transportation.
 - The use of rental cars in lieu of public transportation is not allowed. If personal automobiles are approved for use, mileage will be reimbursed at the current standard rate. Mileage reimbursement will be subject to the same ground transportation limits in the preceding paragraph. Mileage reimbursement will not exceed maximum airfare reimbursement.
- 4. Lodging expenses for up to four (4) consecutive nights will be reimbursed at the single room rate at any of the designated meeting hotels. Awardees are encouraged to stay at AAI-designated meeting hotels. Reimbursement will be limited to the meeting lodging rates published on the AAI website. To receive the published meeting lodging rate, reservations must be made through immunology2023.org/hotels by the discounted housing deadline of April 17, 2023. If the attendee elects to stay at a hotel other than one of the designated meeting hotels, reimbursement will be no greater than the average of the designated meeting hotels (\$235 daily rate, plus taxes). Expenses for extra hotel nights, extra guests, or an adjoining or extra room, will not be reimbursed. To receive reimbursement for lodging expenses, the hotel receipt must be in the name of the awardee.
- 5. Expenses for meals will not be reimbursed nor is alcohol reimbursable.
- 6. Personal expenses such as tips, laundry, valet, travel insurance, entertainment, internet charges, etc., will not be reimbursed.
- 7. AAI membership dues will not be reimbursed.
- 8. Registration for the meeting will be reimbursed at the Early member rate. <u>Award recipients must register for the meeting themselves</u> at <u>immunology2023.org/register</u>. The deadline for Early registration is March 31, 2023. Awardees will not be reimbursed for optional registration items, including event tickets.
- 9. Abstract submission fees will be reimbursed at the member rate for up to 2 abstracts on which the award recipient is a first or last author. Poster printing fees will also be reimbursed for up to 2 posters on which the award recipient is a first or last author.
- 10. Total reimbursement shall not exceed \$1,250.

The AAI reserves the right to deny reimbursement for any charges deemed inappropriate or excessive.

- 1. Expenses will be reimbursed upon the presentation of properly prepared reimbursement requests signed by the claimant and approved by the AAI Executive Office. All expense reimbursement requests must be accompanied by receipts. Requests without receipts will not be honored. Receipts are detailed documents issued by the vendor; credit card statements are not acceptable. Eligible expenses will only be reimbursed after the conclusion of the meeting. Each award recipient must submit a separate expense reimbursement request. All expense reimbursement requests should be submitted through your AAI profile at account.aai.org/login.htm by August 31, 2023.
- 2. Airfare will be reimbursed at the lowest possible excursion rate (economy class) and **must be at an advanced purchase rate or equivalent**. Limits for airfare are based on the circumstances of the travel and economy class/standard airfares offered at the time of travel. Lowest airfares may require stopovers. Upgrades will not be reimbursed and are at the discretion and expense of the traveler. Expenses associated with changing travel arrangements after the initial reservations have been made will not be reimbursed unless the change is a result of program rescheduling. Reimbursement for airfare, including baggage fees, will be limited to a maximum of \$600. If travel does not originate from the award recipient's city of employment, the AAI Office must be notified in advance. Any other exceptions to these conditions must be approved by the AAI Office in advance of purchase.
- 3. Reasonable expenses for ground transportation (cabs, buses, Uber, Lyft, shuttles, etc.) associated with the activity will be reimbursed to the traveler at actual cost. Travelers will be reimbursed for transportation to and from the airport and their home, and to and from the airport and their hotel. Other transportation expenses incurred during the meeting are not reimbursed. Limousine and town car expenses are not generally reimbursed unless equivalent to public transportation.
 - The use of rental cars in lieu of public transportation is not allowed. If personal automobiles are approved for use, mileage will be reimbursed at the current standard rate. Mileage reimbursement will be subject to the same ground transportation limits in the preceding paragraph. Mileage reimbursement will not exceed maximum airfare reimbursement.
- 4. Lodging expenses for up to four (4) consecutive nights will be reimbursed at the single room rate at any of the designated meeting hotels. Awardees are encouraged to stay at AAI-designated meeting hotels. Reimbursement will be limited to the meeting lodging rates published on the AAI website. To receive the published meeting lodging rate, reservations must be made through immunology2023.org/hotels by the discounted housing deadline of April 17, 2023. If the attendee elects to stay at a hotel other than one of the designated meeting hotels, reimbursement will be no greater than the average of the designated meeting hotels (\$235 daily rate, plus taxes). Expenses for extra hotel nights, extra guests, or an adjoining or extra room, will not be reimbursed. To receive reimbursement for lodging expenses, the hotel receipt must be in the name of the awardee.
- 5. Expenses for meals will not be reimbursed nor is alcohol reimbursable.
- 6. Personal expenses such as tips, laundry, valet, travel insurance, entertainment, internet charges, etc., will not be reimbursed.
- 7. AAI membership dues will not be reimbursed.
- 8. Registration for the meeting will be reimbursed at the Early member rate. **Award recipients must register for the meeting themselves** at <u>immunology2023.org/register</u>. The deadline for Early registration is March 31, 2023. Awardees will not be reimbursed for optional registration items, including event tickets.
- 9. Abstract submission fees will be reimbursed at the member rate for up to 2 abstracts on which the award recipient is a first or last author. Poster printing fees will also be reimbursed for up to 2 posters on which the award recipient is a first or last author.
- 10. Total reimbursement shall not exceed \$1,000.

The AAI reserves the right to deny reimbursement for any charges deemed inappropriate or excessive.
